## 1. Welcome and adoption of the Agenda

Scientific and organizing committee of SS1: Josef Eitzinger, Tamas Weidinger, Moshe Mandelmilch.

In case the premises in Jois are not awailable Vienna, AT was suggested as alternative place of SS1.

## 4. Web site and KSP design and implementation

No activities have been done so far regarding the Actions web site and KSP. During the discussion Earth Science institute of SAS (Pavol Nejedlik) and Dublin City University (Mark Roantree) agreed to implement the above mentioned instruments. The work will start in April with the first outline of web site in the end of May.
