TITLE OF CONTRACTED WORK

Microgravimetric prospecting of the Taunusstein site

SUBJECT OF CONTRACTED WORK

Field work will be performed in terms of microgravity measurements on densly spaced profiles in the area approximately 1 hectar on the site in Taunusstein close to Wiesbaden. The profile spacing, as well as the spacing of measurement points on each profile, will be 4 meters. The measurements will be carried out with one or two relative gravimeters of SCINTREX with a precision of 5 to 10 microGal. Height control will be performed using leveling. The contractor will provide three researchers for the field work, who will operate the gravimeters and the leveling. The microgravimetric observations will be corrected by the contractor for the effect of the elevation and eventually of the topography. The observations will be interpreted by the contractor in order to detect any man-made or natural cavities (underground voids) that are realistically detectable withing the accuracy and resolution of the proposed microgravimetric survey, in the special case a cavity of about 80 m³ volume in depths of about 12 to 15 m.

TERMS AND CONDITIONS

The work will be performed from June 11.th 2012 onwards. The job will include 800 measuring points, any additional point is charged with $3 \notin$ /point. Travelling and hotel costs for the team are included in the 3900.- \notin lump sum for the 800 points. Included are gravity field preparation (cleaning if necessary), microgravity measuring, leveling, positioning, correction and data processing as well as a report with a georeferenced graphical presentation of gravity anomalies over the measured field.
